PER CURIAM.

Applying any conceivable standard of review, see *Ryder Sys., Inc. v. Davis*, 33 Fla. L. Weekly D2641 (Fla. 3d DCA Nov. 12, 2008), there is nothing in

the record to support any of the elements of the forum non conveniens doctrine, see *Kinney Sys., Inc. v. Cont'l Ins. Co.*, 674 So. 2d 86 (Fla. 1996), let alone, as is required, all of them. See *Telemundo Network Group, LLC v. Azteca Int'l Corp.*, 957 So. 2d 705 (Fla. 3d DCA 2007). Therefore, the order dismissing the case on that basis is reversed.

Reversed.
